
Dear Mr. Whitby:

Pursuant to O. C. G. A. § 50-18-71, I hereby request the following public records of the Macon-Bibb Industrial Authority:

1. Agreement or lease between the Chamber of Commerce and the local government for the use of the property it occupies for its operations;
2. Agreement between the local government and the Chamber of Commerce for the payment of rent for all public agencies that are housed in the Chamber building;
3. Copy of all budget or financial documents showing all public money paid to the MEDC and any agency, affiliate, or department of the Chamber of Commerce;
4. A description of all services performed by the Chamber of Commerce or any of its agencies for any public agency for pay;
5. Copy of all contracts between MEDC and the Industrial Authority, Macon Water Authority, the government of Macon-Bibb County, and any other instrumentality of government;
6. Copy of any document showing the relationship between the MEDC and the Chamber of Commerce;
7. Copy of the current budget of MEDC on which the payment of public money is based.; and
8. Copy of all transmittal letters or e-mails used to send information to Mayor Robert Reichert in response to my open records request that was submitted to him dated July 14, 2014.

Please respond within the time required by law.
